

ELECTRICITY SALES AGREEMENT COVER PAGE

This Electricity Sales Agreement, which is comprised of this Cover Page, the attached General Terms and Conditions, and any attached riders or other addenda (collectively, this "Agreement"), is entered into on _ by

("Customer"). Capitalized terms used and not

and between energy.me¹ ("energy.me"), and _ defined in this Cover Page have the meanings stated in the General Terms and Conditions. energy.me is licensed by the Pennsylvania Public Utility Commission to sell electricity. energy.me's license number is A-2012-2327584.

TERM

Start Date: For each Location, the Term shall start on the first meter read on or after the Start Date (listed for each Location). If for any reason the account number at any location is not able to be enrolled by the Start Date, it shall be enrolled on the following meter read date (the "Enrollment Date").

End Date: For each Location, the first meter read after _____ (the "End Date"). If for any reason the account number at any location is not able to be enrolled by the Start Date, then the End Date shall become the first meter read after the number of months specified in the Initial Term has passed from the Enrollment Date.

Renewal: Before the end of the Term, energy.me may extend Customer an offer to renew this Agreement. The offer will include, without limitation, a new Term and Contract Price (the "Renewal Notice"). If Customer timely accepts, signs, and returns the Renewal Notice, then the term of this Agreement shall be renewed on the terms in the Renewal Notice (and, in all other respects, on the same terms and conditions in this Agreement). If Customer does not timely accept, sign, and return the Renewal Notice, then unless Customer notifies energy.me that Customer is terminating this Agreement, energy.me shall provide Customer service on a month-to-month basis at a variable price.

PRICING

Each component labeled "Included" is included in the Contract Price. Each component labeled "Pass Through" shall be determined in accordance with the definitions found in the General Terms and Conditions.

Taxes: All applicable Taxes shall be added in the monthly invoice amount.

Payments to Third Parties: If applicable, the Contract Price reflects fees paid to aggregator or brokers for facilitating this Agreement.

Early Termination: A fee of \$0.005/kWh shall be assessed on the estimated amount of unconsumed electricity for the remaining Term of the Agreement, in addition to Termination Damages for each Location. Payments received by energy.me after the invoice due date will be assessed a fee equal to 1.5% of the unpaid balance per month. Customer is responsible for collections costs, including attorney fees.

BILLING

Utility Consolidated Bill - Customer shall receive one invoice from the EDC and shall pay that invoice in accordance with its terms and conditions.

AMENDMENTS TO LOCATIONS

Amendments to locations may be formed and implemented as follows:

- (i) Customer shall request energy.me to add or delete a Location; and
- (ii) energy.me shall provide an addition/deletion form to Customer, which Customer shall complete (including, if the change is an addition, providing Customer's expected monthly kWh electricity consumption for the additional location) ((i) and (ii) collectively constitute the "Request"); and
- (iii) energy.me shall promptly evaluate the Request and, subject to the terms of this Agreement, accept or reject the Request. Acceptances shall be memorialized by an amended Cover Page that is signed by both Parties (the "**Confirmation**").

The Parties adopt the Request and Confirmation method as the means by which the Parties' amendment of Cover Page shall be reduced to writing. The Parties agree not to contest or assert a defense to the validity or enforceability of each amendment entered into.
